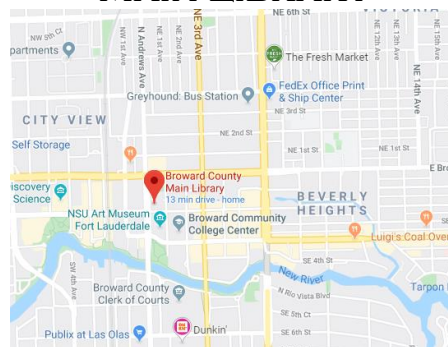

ELIGIBILITY:

PLEASE READ ENTRY FORM IN ITS ENTIRETY

ALL FLORIDA ARTISTS AND GCWS MEMBERS MAY ENTER (2) PAINTINGS,

PLEASE READ THE FINE PRINT: ENTRIES ARE LIMITED TO WATER MEDIA INCLUDING ANY COMBINATION OF WATERCOLOR, TEMPERA, GOUACHE, ACRYLIC, CASEIN, INK, CHARCOAL, GESSO, WATERCOLOR CRAYONS, PENCILS AND PENS INCLUDING METALLIC. ONE MUST EXCLUDE WATER-SOLUBLE OILS AS WELL AS ANY OTHER SIMILAR SUBSTANCE. ACCEPTABLE SURFACES FOR WATERCOLOR ARE SUBSTRATES CREATED FOR WATERMEDIA. FOR EXAMPLE: PAPER, CLAY COATED SURFACES (CLAYBOARD, AQUABOARD, AMPERSAND), SYNTHETIC SURFACES, (YUPO, TIGER RAG), ILLUSTRATION BOARD AND FLAT WATERCOLOR CANVAS. WATERCOLOR COLLAGE IS ACCEPTABLE, BUT NEWSPAPER, MAGAZINE OR NON-WATERCOLOR MATERIAL CUTOUTS WILL NOT BE ACCEPTED. WORKS MUST BE ORIGINAL (NOT A COPY OF ANOTHER ARTIST'S WORK) AND MUST BE COMPLETED BY A SINGLE ARTIST (NOT A COLLABORATION WITH ANOTHER). WORK MUST HAVE BEEN COMPLETED WITHIN THE LAST THREE YEARS; ANY SUBMITTED WORK MUST NOT HAVE BEEN PREVIOUSLY DISPLAYED IN A GCWS JUDGED SHOW. (NOVA SHOW EXEMPT).

ENTRY AND FEES:

ARTISTS MAY ENTER ONE OR TWO PAINTINGS. A **NON-REFUNDABLE FEE** OF \$30 FOR GCWS MEMBERS, \$35 FOR NON-MEMBERS, MUST ACCOMPANY THE ENTRY FORM. NO CHANGES CAN BE MADE AFTER ENTRY IS RECEIVED. NO REFUNDS WILL BE MADE. ALL ENTRIES MUST BE LABELED ON THE BACK (UPPER RIGHT) WITH ARTIST'S NAME, PHONE NUMBER, TITLE, VALUE AND WHETHER OR NOT THE PAINTING IS FOR SALE.

SIZING AND FRAMING REQUIREMENTS:

ALL TYPES OF FRAMES ARE ACCEPTABLE EXCEPT THOSE THAT ARE ORNATE OR HEAVY. SAW TOOTH HANGERS ARE NOT PERMITTED. **MAXIMUM SIZE FRAME IS LESS THAN 48" IN ANY DIRECTION.** MATS ARE OPTIONAL WITH NO COLOR RESTRICTIONS. WORK MUST BE STURDILY FRAMED UNDER PLEXIGLAS OR GLASS, WIRED AND READY FOR HANGING (WORK WILL BE REJECTED IF IT DOES NOT COMPLY AND FEES WILL NOT BE REFUNDED.)

CONDITIONS AND LIABILITIES:

THE SUBMISSION OF ENTRIES TO THIS COMPETITION SHALL CONSTITUTE AN AGREEMENT ON THE PART OF THE ARTIST TO THE TERMS AND CONDITIONS AS SET FORTH IN THIS PROSPECTUS.
