



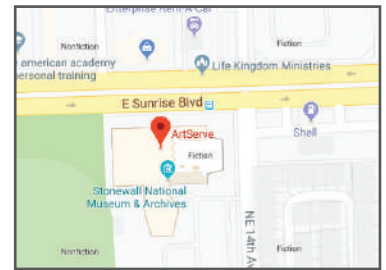

## **ELIGIBILITY**

GCWS members may enter two (2) paintings. A non-refundable fee of **\$30 for members** is required with the entry form. No changes after entry. No refunds. All entries must be labeled on the back (upper right) with artist's name, phone number, title, value and whether or not the painting is for sale.

**Please Read the Fine Print:** Entries are limited to water media (including watercolor, tempera, gouache, acrylic, casein, ink, charcoal, gesso, watercolor crayons, pens and pencils. Water-soluble oils are excluded) art on paper, clayboard, aquaboard, yupo, tiger rag, illustration and flat watercolor canvas. Water media collage is acceptable, but magazine, newspaper and non-water media material is excluded). Works must be original (not a copy of another artist's work) and must be completed by a single artist (not a collaboration with another). **Work must be current (completed within the LAST THREE YEARS) and not previously submitted to a GCWS judged show.**

No nudes please. All entries must be covered with Plexiglas (preferred) or glass. Mats are optional with no color restrictions. All types of frames are permitted, except those too ornate or too heavy. Wired, please. No sawtooth hangers. Maximum frame size less than 48" in any direction. No beads, feathers, glitter or other embellishments.

The submission of entries to this competition shall constitute an agreement on the part of the artist to the terms and conditions as set forth in this prospectus.



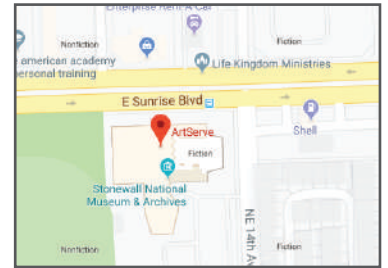
